We will provide substantial proof that perjury has been committed or supported by leaders at all levels. Including reports from our personal doctor, psychotherapists, Melodie Bissell CEO Plan to Protect and other witnesses

The Buschmans, supported by Pastor Les Bon-Bernard, Elder Orr and Elder's appointed Mediator Dr Brent Kinnie have borne false witness against us and abused their power as leaders & lay ministry leaders to shut us out of the ministry that God has called us to.
