Before 2010 B&J had an excellent relationship with Greg McCombes at FAC. Never quite sure why he moved out of marriage & family work as he was excellent. Before FAC moved from Glenmore Trail we were frankly envious of how FAC ran their marriage ministry! Very vibrant!

However during their time at FAC 2013-2016 Barry & Jennifer would hear of others who had been hurt by happenings in the marriage ministry and dropped out.

Fall 2010 Invited to dinner with Scot and Tara Weatherford at our friend Carol Lawrence's home. Carol was very concerned about the state of marriage & family

- ministry at FAC. She hoped we might make a difference. Carol has since died. We sent a note to Scot but no response
- 11.11.11 Met with Les Bon-Benard as Relationship Central reps 2 years before joining FAC. Shared our work in marriage & family. Hoped he would introduce some of the courses. Followed up but no response
- 28.10.13 Urgent call from Jamie Unruh @ FAC have 10 couples ready for Pre_Marriage Couple and facilitator has dropped out. Can B&J recommend someone? B&J think about it 5 minutes and call back and say they will do it. We established a really good working relationship with Jamie from beginning. Although some concerns assistants were privy to confidential information. "We have a young couple who recently completed the Preparing for Marriage course and wanted to do the P&E assessment. It looks like they have a few issues that they need a more seasoned mentor couple to walk them through. Would you be available to mentor them? Jamie

Agreed to jointly contact National Director - never happened but Ron contacted her separately . Jennifer challenged Ron on the fact that First Alliance did not take Marriage Ministry seriously.

- 15.12.14 Email from Ron "Thank you both for making the time to visit last week; I do enjoy our time together. Over the next week I'll make of list of "projects" where I could use some additional support, and if you'd like, you can pick from there your areas of interest" Nothing was ever received.
- 15.12.14 email from Ron "No meals possible for next Marriage Course" No discussion he can't get Harvest Meals to help us
- 16.1.15 sent home based marriage course video to team
- 18.12.14 (date question) Our surprise Ron arrives at Seniors lunch to give a presentation on Marriage Matter Ministry. We are not forewarned us as Marriage Matters team members & regular seniors attendees? Ron would later be critical of the seniors for making too much noise while he spoke. A trait he would show to others who displeased him
- 17.12.14 December meeting at Ron & Teresa with Brent, Rhea, Patrick & Karen Had to invite ourselves to meeting major discussion on whether food would be served. See email. Barry obviously upset Ron by insisting meal must be part of course. Ron would not share financial info. Only Teresa saved day. Push for regular team meetings ignored
- 23.12.14 Meals on again. No details. No financial details

- 19.1.15 Fac Marriage Ministry Social 6 couples & Ron confidentiality concerns over comments made in the meeting by Randy Aspinal and group banter about a couple who had taken prep-course. Ron gave a vision...His Dream. Went on for a long time. Ron did not share copy of dream ahead or after. We requested a copy. Mike asked "Ron sum it up with what are the 5 most important issues?" No response.

B&J share interest in running Parenting Course mentioned?, _ Ron "will do it in 2016", B&J wanting to active outside church with couples & families.

Every thing is strategic whatever that means? Ron shares his & Teresa's problems with P&E and will not let Marriage Matters couples who took training see their full reports

- 23.1.15 Sent Marriage Prep Webinar to Patrick & Karen (had previously sent training info)
- 24.2.15 Offer to help Shane & Kim in 911 mentoring
- 21-28.1.15 Exchange emails B&J & Ron on need to meet important issue before Marriage Course starts. Very challenging for B&J to remain calm with Ron's aggressive emails
- 27.1.15 Ron took us out of ministry without our knowledge or discussion based on suspicion. He had spoken with our co-facilitators and asked them to replace us. He did this first in an email that arrived late in evening. We were too tired to read it after spending 2 days preparing for our meeting with him. Would not notice till later.
- 28.1.15 Meeting Ron B&J raised confidentiality concerns that were ignored. Based on suspicions B&J were creating disharmony and had to step down from ministry. At this Barry called a Ron a control freak and stormed out with Jennifer. After discussions Jennifer decided to return and under great pressure and insistence from Ron confirmed Randy Aspinal was the person sharing confidential couples information.
- 28.1.15 Later that night Ron called and rescinded decision and B&J could run course no apology or attempt to help us talk things over with couple he had planned to replace us with
- 29,1,15 Ron gives a strange & rushed message to the MC & MPC group at dinner about on confidentiality no prior discussion with anyone. Jennifer asked several times for a confidentiality document for all to sign. Nothing done.

- 18.2.15 Brad Boshmans email confirming he, Ron and our National Director has been in discussions for more than two weeks to hold a Marriage & Marriage training event at FAC' Brad noted Ron is very pleased to have B&J on his team. Hurt B&J a little ,things being done behind their backs' Following night Ron's admission
- 20.2.15 Invite from Ron to run proposed new Marriage Course start April 9. He notes maybe couples would come out of Brad's training event . Its somewhat of a mystery who attends we know of two couples, one from FAC
- 23.2.15 B&J respond to Ron we are off on 3 weeks vacation in eastern USA happy to help 2 weeks in beginning and last few weeks of upcoming marriage course. Never heard back from Ron
- 4.3.15 B&J email team & 100 couples about Brads training what does Ron do?
- 3.5.15 Marriage Matters Bible Study we were on vacation
- 7.3.15 Marriage Course Training event by Brad from Foothills at FAC 5 churches represented. 12 couples Who from FAC unknown
- 7.3.15 Email from Brad re training event 12 couples attended thanks to B&J for your help in promoting
- 12.3.15 Last night Marriage Course strange situation over group photo Ron & Teresa would not join group
- 13.6.15 Marriage Mentoring training unable to attend
- 18.6.15 Marriage Matters Bible study three couples active in marriage work who should have attended did not ever

Summer 2015 On Main Street @ FAC Marianne Aspinal shares with B&J her concerns & worries about a couple she and Randy are mentoring. Gives ages and ethic backgrounds. We advise her to speak to Ron or Fern. We believe it shows 1/2 P&E training insufficient. Likely some role play exercises needed and a

- 10.9.15 Attended First Couples Cafe event. Strange comment from Teresa over we were first to sign up. No request to help that evening. First indicator of the 'Core' group at work
- 16 .9.15 Marriage Matters Bible Study. Barry asked for proper team meetings with agendas, reports, financials, upcoming events ets. Gave Mens Ministry model with clearly irritated Ron . Jennifer asks for better communication. Ron said he does have resources for newsletter. Three couples active in marriage work who should have attended did not ever
- 3.10.15 Relationship Central Meetings in Calgary with our national director Elaine Young. Brad from Foothills was there. Brad is always supportive of our work
- 4.10.15 National Director Elaine Young in town & introduced to James re possible visit by Nicky and Sila Lee extending their trip to Haiifax. James very supportive of idea as he has worked with the ministry says contact Les
- 1.11.15 Second Couples Cafe Event we did not attend
- 10.10.15 Contact Les by email re potential Nicky & Sila visiting Calgary. **Took 6 weeks** to arrange
- 24.11.15 Meeting Les & Ron re Nicky & Sill Lee starts 10 minutes late, Les looks at watch and says no time chit chat. 9 minute meeting basically no discussion just a verdict (Halifax event sold out). **Asked if we got another church involved would FAC support it? NO.** But Les said he so appreciates us coming forward with the idea doesn't happen very often! We wondered why? Ron Buschman said Nicky & Sila would not be a big enough draw! Only meeting with Les & any form of communication in 2 1/2 years in this ministry under his direction and to current date. Was the CORE team consulted?
- 5.12.15 email from Ron..he an Les have discussed again and its no. Did the team get a chance to discuss option?
- Sept 15 to January 2016 Ongoing brief chats/emails/messages with James about getting together
- 28.1.16 Meeting James seemed sympathetic wait 5 weeks for me to work on it. Barry persisted but then James became really ill . See messages with James

- 29.1.16 Ron & Teresa accepted our hospitality as part of a 24 person grief hospitality evening at our house. Not a word! If they were so unhappy with us why not hang behind?
- 10.2.16 Marriage event Garry Thomas @ Centre Street . The inner CORE Marriage Matters team were out in force! Not a word mentioned!
- 11.2.16. Barry taking photos Garry Thomas singles event @ FAC . Email from Ron he was very appreciative!
- 16.3.16 Note from Les.- James had referred requests to him and he referred us back to Ron when he returns in April. Huge disappointment! Sending us back to an abuser. Difficult to trust the system after this. Needed to pull back and pray!
- 12/19.5.16 Vancouver vacation with family
- 22.5.16 B&J write to Brad Young seeing if we can help in marriage & family in new FAC church plant The Exchange. No response
- 24.5.16 email request from Ron need meet within 5 days to get our opinions of him and ministry. Why the urgency? Did email to Brad Young set this off? Was this because Les & Dawn had agreed to do the January 2017 Marriage Course and we needed to be got rid of?
- 27.5.16 Meeting Ron joined by Teresa. We were totally deceived by the purpose of meeting. Teresa appeared to be there to record meeting. Tried to share our thoughts but stopped by strange use of Matthew 18:15. Someone had challenged his authority in public. No details or witnesses. Basically B&J are out of the ministry, they have a core group of couples running it and Les will run a Marriage Course in January 2017. As we left Jenifer made it clear she wished to talk to Ron privately. See fuller meeting report
- 31.5.16 Email from Anne Freeman for the Couples Cafe on June 10 now notes Teresa Buschman as a Marriage Ministry Team Leader. First B&J had heard this. The theme for this event "is being a great team player."
- 1.6.16 strange email from Ron "I left our meeting last Friday feeling I had addressed a significant issue you felt was under my control, and yet wasn't. Therefore, your behavior toward me this afternoon was confusing. So I again offer to make myself available to meet with you, should you wish to discuss this new issue(s) with me. Please let me know" Clearly oblivious to the pain he has caused us

while Barry waits for Jennifer to come out of Discovery Land on shouts out hi Barry "Hi Barry" from by the new food serve area....felt like a gloating - Les comes up and shakes my hand assures me we will be meeting soon...felt a little weird

6.7.6 member of Christian community confirms conversation in April or early May with Ron about the conflicts between him and the Pendergasts and between us and other team members resulting in our being removed from Marriage team. Could seriously impact our role with Marriage Course's. Who else has Ron shared this with?

In the end our opinion that First Alliance is not committed to Marriage & Family ministry - many problems in past

7.7.16 Meeting with Tim Les Pat

Les - all he knew was Ron tried to reach out to us without success. Knew nothing of any conflict. Yes he had agreed to do the marriage course so Ron must have talked to him? How up to date is he? Ron agreed to get rid of us? Was that why the 5 days was urgent? Did the team get consulted? Who else j-knows about the MC 2017?

Les disagreed this was spiritual abuse though doesn't seem to understand what it is. Will go back and investigate - a real conflict of interest?

Only second time since being at FAC we have been in a meeting of any kind with Les

24.7.16 Barry & Jennifer come into the church early get Photo Exhibit ready - Ron insists on hugging Jennifer but Barry walks pass him with photo stuff. Teresa looks very tense and serious. Again felt like Ron needed to gloat
