Hi Brent

I do have one more question and a few concerns.

When you interviewed Ron, was Les present?

I hope he was not as that would be a conflict. Having Les present at the last meeting may also have been a conflict. This situation may not be very flattering to Les's leadership and overseeing of this area of his ministry. If what I am saying is true, it is far too easy for Les to be in a protective stance concerning Ron.

The mediation process requires a certain procedural expectations and a well-defined process that is fair and safe. Les influencing Ron's response would not be fair, and Les continually proclaiming there is two sides to a story belittles the Pendergast testimony. Moreover, I am sure you, as we all, know there is two sides to a story.

It would be one thing if Les was only a supportive participant, but that is not his position as the person in charge of the area of concern. He may naturally be protective and controlling.

With all that considered, I would like to recommend that the next meeting we are alone with only Ron & Teresa added. Giving you a chance to hear from the parties directly involved. If Les requires a separate meeting with the Pendergasts, or concerns of Elders, to deal with any allegation towards him, that can be a different meeting.

I would also suggest that you provide a written process so the Pendergasts, and all involved, so we can see where we are going and how we are getting there. I know this is time consuming, I do, as I have been at this for almost eight months, but in order to help all parties know they are not being led into the lions den, it may be good to provide a road map. This may also speed up a process that should have been dealt with in two to three months.

One thing the Elders should consider is what if any process the Church has in place to deal with issues concerning its participants. The care of these sheep is ultimately their greatest responsibility. Sometimes that means protecting them from the very people who are suppose to shepherd them. Standing up against the shepherds is a very intimidating thing for the sheep.

I will leave this with you for your consideration.

- 1. The Prendergasts appealed to The Elders to deal with this situation, through an email to the Chair of The Elder's Board. They did this as they and I perceived a conflict of interest with Les as the mediator. They never received any word back from the elders.
- 2. You came on the seen as the mediator. It was not clarified how you were chosen.

The assumption is you are representing the Elders in this mediation. My questing is. Is that true? Or Did Les seek you out to do this? Is the Elders board aware of your involvement in this mediation? Or is there another process that brought you to the table?

The Prendergast's and I have these questions and would like it if you could shed some light on them for us. It strikes me as odd that the chair did not respond to the Prendergast email. I do not want to re-write the Chair to ask these questions if you can help us understand the process.
